

Collection of Goods & Authorized Release Form

Your Lots

Lower Falls Wine Co. will release your goods to you as soon as possible. The inherent nature of fine wine, spirits, and ale requires that due care be taken in storage and transport. We request your partnership in making sure no harm arises during storage, collection or transportation. Bottles that are old or unusually shaped need to be collected in person. Skinner and Lower Falls Wine has the right to use our discretion when the circumstance arises.

When someone other than the invoiced party collects your lots, **Lower Falls Wine Co. must have a signed Authorized Release Form (p. 2).**

Pick-up

Collection is available **by prior arrangement** only at:

Please schedule your pick up by contacting Lower Falls Wine Co. (617-332-3000, staff@lowerfallswine.com) a minimum of **3 business days in advance**. Full payment of all applicable charges must be received prior to release of any goods. Goods will only be released to those over twenty-one years of age. Proof of age will be required.

Local Delivery

Lower Falls Wine Co. will deliver inside Route 495 for a fee. Deliveries are made Monday through Friday during normal business hours. All fees associated with delivery must be paid in advance. Lower Falls Wine Co. reserves the right to (re)package items if deemed necessary for a nominal fee. Goods will only be delivered to, and must be signed for by, someone over twenty-one years of age.

Transportation

All bidders should make themselves aware of the restrictions imposed by various states and countries with regard to the importation of alcoholic beverages **prior** to participation in any auction to ensure compliance with local and federal statutes. Buyers are responsible for researching, understanding, and complying with all permit or license requirements before the collection and transport of purchases. For non-local delivery it is the buyer's sole responsibility to contract a third-party for collection and delivery service and ensure the third party is correctly licensed to transport alcohol.

For any third-party collections, an Authorized Release Form (p. 2) must be signed and submitted to Lower Falls Wine Co. prior to pick-up.

Massachusetts law prohibits the shipment of alcohol out of state by common carriers (FedEx, UPS, etc.)

Due to the delicate nature of old, rare and spirits bottles, some are not recommended for shipment and we may require you to collect in person.

Storage

All merchandise purchased must be paid for and removed from Lower Falls Wine's premises within thirty days of the auction. Lower Falls Wine Co. may impose a monthly interest charges of 1.5% of the purchase price of any item not removed within thirty days of the date of sale. For long term storage we recommend International Wine Vault (617.739.4401, www.internationalwinevault.com).

Fine Wines, Spirits & Ales Authorized Release Form

Important:

When using a shipping company or someone other than the invoiced party to collect your purchases, please fill out and submit this form to Lower Falls Wine Co. Wine, spirits, and ales will only be released to those over 21 years of age. Proof of age will be required.

Lots will not be released to any company or individual other than the buyer without a signed Authorized Release Form submitted to Lower Falls Wine Co. prior to pick up. Please keep in mind payment must be made to Skinner Inc. once the auction has closed and collection/delivery arrangements must be made with Lower Falls Wine Co. a minimum of 3 business days before collection. Any applicable fees to Lower Falls Wine Co. or the designated third party shipping company must be paid prior to the release of goods.
